Process to Become MADD Level I Campus Chapter

A Level I Campus Chapter is established and operated by a Chapter Coordinator and Student Coordinator through a sponsorship agreement with a MADD State Organization. The Chapter Coordinator is a faculty advisor from the chapter's university or college. The state organization or national office may designate a Level II chapter to be a campus chapter's sponsor with the Level II chapter's concurrence when the proximity and resource capability of the Level II chapter favor such an arrangement. In the absence of a state organization, a campus chapter may be sponsored by a local Level II chapter or the national office.

Requirements

1. Satisfy the requirements of chapter's university or college to become a recognized campus entity. Obtain letter of support or recognition from chapter's school.
2. Complete campus chapter research.
3. Designate a chapter coordinator and a student coordinator. (Chapter coordinator must be a faculty member.)
4. Complete a Level I Campus Chapter Sponsorship Agreement.
 - (a) Campus Chapter Sponsorship Agreements must be authorized by the state organization and signed by the state organization chairperson and the chapter coordinator and student coordinator.
 - (b) In the event the state organization designates a Level II chapter to sponsor the campus chapter, the sponsorship agreement must also be authorized by the Level II chapter's executive committee and signed by the Level II chapter's president.
5. Choose name of campus chapter. Obtain approval of name from sponsor.
5. Submit research, sponsorship agreement, letter of support or recognition from chapter's university or college, and name of campus chapter to Regional Coordinator at national office.
6. National office issues campus chapter charter certificate. Charter is renewed annually.
